MEMORANDUM OF ASSOCIATION OF CARMEL EDUCATION SOCIETY.

NAME:

The name of the Society shall be CARMEL EDUCATION SOCIETY.

OFFICE:

2. The Principal office of the Society shall be situated in the State of Andhra Pradesh. Its present address is

Door No. 2/133,  
Carmel Convent,  
Macheri (Adilabad Dist.) Andhra Pradesh  
Luxettipet - Teluk.

OBJECTS:

3. This Society is being formed by the Congregation of the Mother of Carmel, a Religious Congregation of Roman Catholic Nuns, hereinafter referred to as 'the Congregation' for the following objects:

- a. To conduct, support and promote secular educational activities in all its branches, including teachers training to all sections of the public.
- b. To conduct and encourage medical aid, assistance and training in all its Branches irrespective of religion, race, caste, community or social status.
- c. For the promotion and realisation of these objects and purposes:-  
To acquire immoveable property of any tenure, mainly in the State of Andhra Pradesh but also in any other part of India, according to the needs of the Society may require, with or without buildings and structures, lease, exchange, gift or any other form of acquisition at such rates, terms and conditions as the Governing Body of the Society may agree to.
- d. To construct such buildings or buildings and structures as may be necessary and from time to time improve, alter or extend the same or any part or parts thereof.
- e. To print, publish and exhibit films, journals, periodicals, books lectures and other reading and pictorial matter for diffusion of useful knowledge and in keeping with the educational, medical, charitable and moral ideals of the Society and Congregation.
- f. To hold and conduct classes, lectures, conferences, seminars and competitions, and to give scholarships, freships, diplomas, certificates and awards as and when thought fit.
- g. To equip all or any of these undertakings and to provide residential accommodation, equipment and maintenance, either free of cost or for consideration, to teachers, pupils, staff, servants and others connected with the work of the Society and to educate, train and assist financially or otherwise in the education and training of teachers, students, orphans and other personnel for the purposes of the Society.
- h. To maintain a Repair Fund to meet the expenses of a capital nature and to pay into such Fund moneys at such times and in such amounts as the Governing Body may from time to time decide.
- i. To establish and maintain Reserve Funds of such amount as the Governing Body may think fit, for the promotion of the activities of the Society, including the extension of the buildings and structures.
- j. To raise funds and to receive and use any gift, donation or foundation in cash or other moveable property of all descriptions and to undertake and carry out the offices, duties and functions of trustees, managers and administrators solely or jointly with other, in respect of any such gifts, donations and foundations.

m) To do all such other lawful acts and deeds as are essential or conducive to the attainment of the objects of the Society.

## RULES AND REGULATIONS OF CARMEL EDUCATION SOCIETY.

The name of the Society is the Carmel Education Society.

Location: The Society shall be located at A.C.C. Mancherla Door No.2/133 Street No.5, Taluk- Luxettipet, District Adilabad, Andhra Pradesh

### Interpretation:

1. In these Rules and Regulations unless there be anything in the context repugnant or inconsistent therewith:-
  - a. 'The Society shall mean the "Carmel Education Society".
  - b. 'Governing Body shall mean the governing body of the Society constituted as provided by these Rules and Regulations.
  - c. 'Trustee or Trustees' shall mean such member or members of the Governing Body as is or are constituted the Trustee or Trustees of the Society as provided by these Rules and Regulations.
  - d. 'The Act' shall mean the Public Societies Registration Act I of 1950 Fasli or any modification or re-enactment thereof for the time being in force.
  - e. 'Superior' shall mean the head of the time being of the Religious Congregation of the mother of Carmel at Mancherla (hereinafter referred to as the Congregation) or the member of the Congregation for the time being discharging her functions and powers.
  - f. '1st Asst. Superior' shall mean the member of the congregation for the time being appointed 1st Asst. Superior by the congregation.
  - g. '2nd Asst. Superior' shall mean such person who is holding the office of the 2nd Asst. Superior by appointment of the congregation.
  - h. Words importing the singular number shall be deemed to include the plural and vice versa. The pronoun 'he' and its derivative will refer equally to males male and female.

### Membership:

The members of the Society shall include members of the Congregation and such other person or persons as may from time to time be called upon in writing by the Governing Body to be members of the Society and who shall intimate their consent in writing to the governing body to be such members and shall sign the Register of members maintained by the Society in token of such consent. The number of members of the Governing Body shall be five. The Governing Body shall have power to decide by majority or votes, without being bound to give any reason for such action, to terminate any time in writing the membership of any member of the Society, and on termination of his membership as aforesaid, such member shall forthwith cease to be a member of the Society and to have any right or claim whatsoever any rights or privileges of membership of the society and of the Governing Body or to any property of the Society.

GO BY MEMORANDUM RULES AND REGULATIONS:

Every member of the Society shall be bound by the Provisions of the Memorandum of Association of the Society and these rules and Regulations and by all Rules and Regulations, bye-laws and decisions from time to time made or taken by the Society in General Meeting or by the Governing Body.

TERMINATION OF MEMBERSHIP:

Membership of the Society shall ipso facto terminate if:

- a. A member dies or leaves or is excluded from the congregation or permanently leaves India, or
- tenders her resignation in writing to the Society, or
- her membership is terminated as provided by these Rules and Regulations.

L. BODY:

The General Body shall consist of members who have taken legal notice of the need to increase the governing body. The governing body is nominated by the Governing Body.

MANING BODY:

The management and control of the Society shall be vested in a Superior, 1st Asst. Superior and 2nd Asst. Superior, who shall be members who shall not be liable to retirement from the Governing Body while they hold their respective offices. The other members of the Governing Body shall be elected at the Annual General Meeting of the Society. Any vacancy occurring in the Governing Body, those of the Ex-officio members, shall be filled by the Governing Body by majority of votes, and the person so appointed shall hold office only until the next Annual General Meeting of the Society, but the Governing Body shall have the power to act notwithstanding any vacancy in its number.

The Superior and in her absence, the 1st Asst. Superior and in absence of both, the 2nd Asst. Superior shall be the chairman at meetings of the Society and of the Governing Body, in the absence of all of them, the members of the Society or of the Governing Body as the case may be, present at a meeting may elect any other member of the Governing Body failing such, any other member of the Society as Chairman of the meeting. The Superior or 1st Asst. Superior shall convene all meetings of the Governing Body at time or place as may seem fit.

POWERS OF THE GOVERNING BODY:

- 8. The Governing Body shall have the entire control and management of the business and affairs of the Society and shall have all such powers of the Society enabling them generally to carry out the objects of the Society as are by the Act required to be exercised or done by the Society in General meeting. The Governing Body shall also have powers from time to time make, vary or/and repeal bye-laws for the transaction and regulation of the business and affairs both of
