

- g. To equip ell ar any of these undertakings and to provide residential seconmodation, equipment and maintenance, either free of cost or for consideration, to terchers, pupils, staff, servants and others connected with the work of the Society and to aducate, train and easist financially or otherwise in the education and training of teachers, students, orphans and other personnel for the purposes of the Society.


- In these Rules and Regulations unders there be snything in the context repugnant or inconsistant therewith:


